He remains available for consultation to address concerns and provide clarity on these standards, actively engaging with different specialties to emphasize their roles and responsibilities within the committee. For instance, <b>Nominee 11</b> advocates for the use of CAP protocols on breast biopsies and resection specimens to enhance the evaluation of cancer, demonstrating his commitment to improving patient care. During our recent COC accreditation survey, he provided invaluable insight and guidance, highlighting the unique challenges faced by our program, such as the absence of employed oncologists, and how we effectively coordinate patient care despite this.
An outstanding CLP possesses a clear understanding of the National Cancer Database (NCDB) reporting tools and uses them effectively to assess program performance. Nominee 11's contributions extend beyond mere participation; he actively educates the committee on tracking quality metrics, particularly focusing on breast, colon, and lung cancer outcomes. He presents data on Standard 2.2, discussing the percentage of patients receiving appropriate care in terms of adjuvant radiation, chemotherapy, immunotherapy, endocrine therapy, and surgical interventions, comparing our performance to state and national benchmarks. Additionally, he addresses the issue of uninsured patients, proposing strategies to improve access to care in non-Medicaid expanded states. Furthermore, Nominee 11 plays a pivotal role in communicating national standards to the team, ensuring continuous compliance throughout the year. He actively participates in cancer registry quality control and encourages real-time abstracting to provide timely feedback on cancer outcomes. His involvement in brainstorming sessions and quality improvement initiatives, such as standardizing MRI reporting for rectal cancers, underscores his dedication to enhancing patient outcomes. He also is integral year-to-year in selecting, reviewing, and determining needed action plans for standard 7.2 with monitoring concordance with evidence based guidelines
