Dear Senator Murphy:

On behalf of the more than 82,000 members of the American College of Surgeons (ACS), I would like to express our support for the Background Check Expansion Act of 2021 (S. 529). This legislation would require all sales to go through the National Instant Criminal Background Check System (NICS) as established under the Brady Handgun and Violence and Prevention Act. This legislation is an important step to addressing the public health crisis.

In 2018, the American College of Surgeons Committee on Trauma (ACS COT) released a set of thirteen recommendations from its Firearm Strategy Team (FAST) Workgroup. These proposals include strategies and tactics to reduce firearm injury, death, and disability in the United States. One of these recommendations includes support for a robust and accurate background check for all firearm purchases and transfers. We applaud you for introducing this legislation to keep firearms from dangerous individuals and help reduce the number of people impacted by firearm-related violence.

Again, thank you for your leadership on this vital issue. We look forward to working with you to ensure enactment of this important legislation and on future efforts to address the firearm-related public health crisis.
